Re: ICAP Global Derivatives Limited – Regulation 40.6 Rule Certification – Amended Rulebook

Ladies and Gentlemen:

Pursuant to Section 5c(c) of the Commodity Exchange Act, as amended (the "Act"), and Section 40.6(a) of the regulations of the Commodity Futures Trading Commission (the "Commission"), ICAP Global Derivatives Limited ("IGDL"), a registered swap execution facility, hereby notifies the Commission that it has amended Confidential Chapter 9 to its Rulebook as provided in Exhibit A.

A concise explanation and analysis of the amendments to the Rulebook and their compliance with applicable provisions of the Act and the Commission regulations thereunder is attached hereto as Exhibit A. A clean copy of confidential Chapter 9 is attached hereto as Exhibit B, and a copy of confidential Chapter 9 marked to show changes from the version last submitted to the Commission is attached hereto as Exhibit C. A request for confidential treatment of Exhibits B and C is being simultaneously submitted to the Commission and a copy of that request is included with this submission.

The amendments to the Rulebook will become effective on September 26, 2017. IGDL certifies that the amendments comply with the requirements of the Act and the rules and regulations of the Commission promulgated thereunder. IGDL has reviewed the swap execution facility core principles ("Core Principles") as set forth in the Act and has determined that the amendments impact the Core Principles identified in Exhibit A.


